

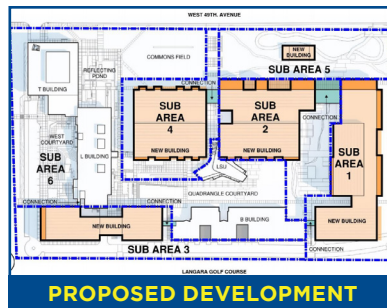
# NOTICE OF PUBLIC HEARING

February 25, 2021

## 100 West 49th Avenue (Langara College)

Vancouver City Council will hold a Public Hearing on:

**Thursday, March 11, 2021 at 6:00 pm**  
to be convened by electronic means



Council will consider amendments to CD-1 (55) (Comprehensive Development) District to accommodate a phased masterplan for the Langara College campus which includes:

- five academic and community buildings:
  - Sub-areas 1, 2 and 4: a maximum building height of six storeys and 31 m (101 ft.);
  - Sub-area 3: a maximum building height of four storeys and 21 m (69 ft.);
  - Sub-area 5: a single-storey Indigenous Meeting House at 11 m (36 ft.) in height;
- a total floor area of 134,641 sq. m (1,449,264 sq. ft.) for the site; and
- a total floor space ratio (FSR) of 1.66 campus-wide.

Subsequent development permits for specific buildings will be submitted individually with each phase of expansion.

This application is being considered under the *Langara College Policy Statement*.
