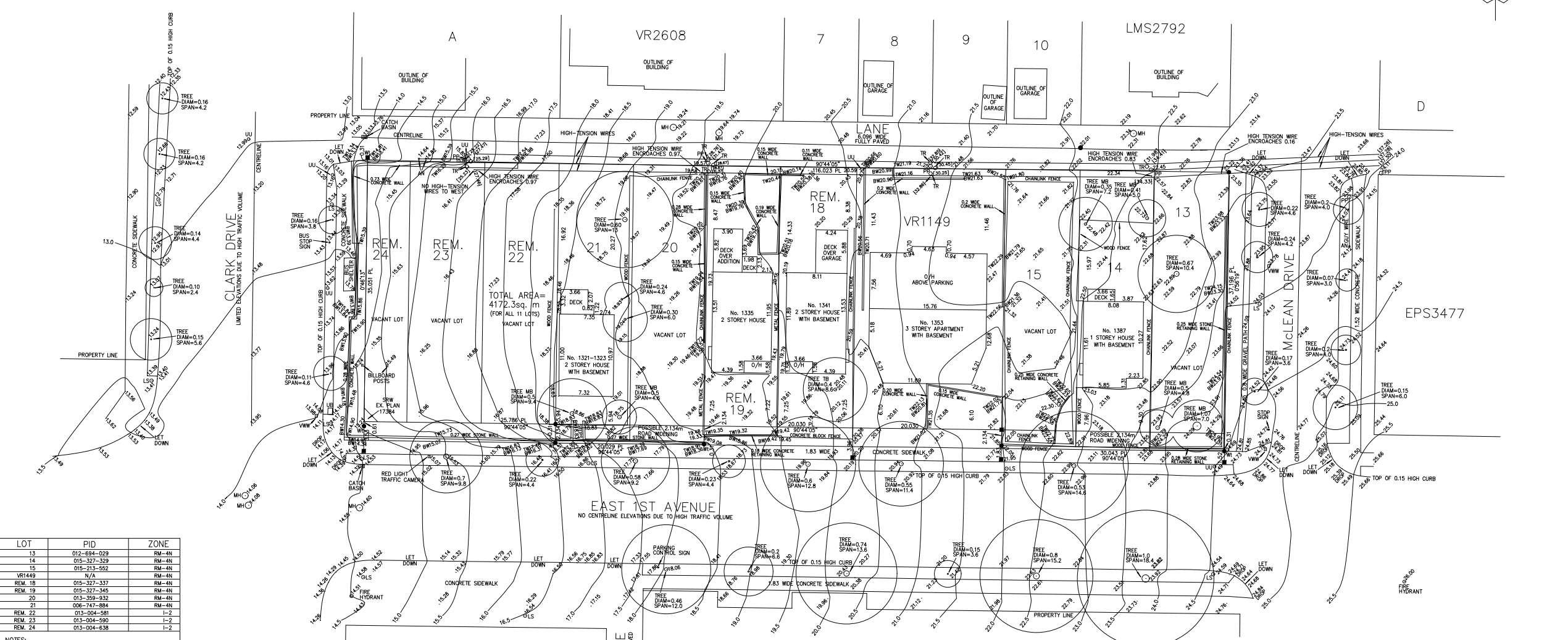
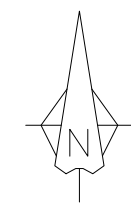


PLAN SHOWING LOCATION OF ELEVATIONS AND SETBACKS ON:
