

# NOTICE OF PUBLIC HEARING

Vancouver City Council will hold a Public Hearing on:

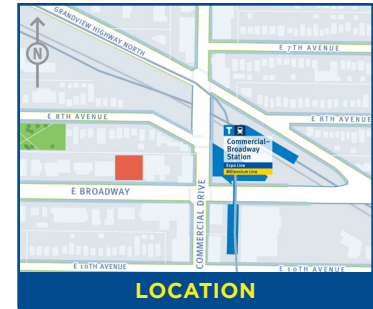
**Tuesday, Sept 15, 2020 at 6 pm  
to be convened by electronic means**

Council will consider amendments to CD-1 (715) (Comprehensive Development) District to allow for two additional storeys to accommodate a 12-storey mixed-use building including:

- 114 secured rental residential units, including 23 below-market rental units and 91 market rental units;
- commercial uses at grade;
- an increase to the permitted floor space ratio (FSR) from 4.0 to 5.0;
- an increase to the maximum building height from 33.2 m (108.9 ft) to 36.5 m (119.8 ft);
- 70 underground parking spaces and 217 bicycle spaces.

This application is being considered under the *Grandview-Woodland Community Plan* and the *Below-Market Rental Housing Policy for Rezoning*s.
