NOTICE OF PUBLIC HEARING

1780 East Broadway

Vancouver City Council will hold a Public Hearing on: Thursday, July 7, 2022 at 6:00 pm to be convened by electronic means

Council will consider amendments to the Zoning and Development By-law. If approved, the zoning would change from C-3A (Commercial) District to CD-1 (Comprehensive Development) District. The mixed-use development consists of three towers of 24, 28, and 29-storeys above a retail base with:

- 215 strata-titled residential units and 438 secured rental units including 93 at below-market rates
- a large format grocery store, retail, restaurant, office space, and public plaza
- a floor area of 55,989 sq. m (602,662 sq. ft.)
- a floor space ratio (FSR) of 5.7
- a maximum building height of 108.3 m (355 ft.)
- 444 parking spaces and 1,390 bicycle spaces

This rezoning application is being considered under the *Grandview-Woodland Community Plan.*
