

NOTICE OF PUBLIC HEARING

5-15 West 2nd Avenue and 1751 Ontario Street

Vancouver City Council will hold a Public Hearing on:

**Thursday, April 14, 2022 at 6:00 pm
to be convened by electronic means**



Council will consider amendments to the Zoning and Development By-law. If approved, the zoning would change from M-2 (Industrial) District to CD-1 (Comprehensive Development) District.

The 18-storey mixed-use building includes:

- 122 secured market rental units, of which 20% of the residential floor area will be below-market rental units
- A floor space ratio (FSR) of 7.91
- A building height of 58.6 m (192 ft.)
- 53 parking spaces and 239 bicycle spaces

The application is being considered under the *Southeast False Creek Official Development Plan* and the *Below-Market Rental Housing Policy for Rezoning*s.
