

NOTICE OF PUBLIC HEARING

5910-5998 Cambie Street

Vancouver City Council will hold a Public Hearing on:

Tuesday, March 9, 2021 at 6:00 pm
to be convened by electronic means

Council will consider amendments to the Zoning and Development By-law. If approved, the zoning would change from RT-2 (Residential) District to CD-1 (Comprehensive Development) District. The mixed-use development consists of a 15-storey hotel tower and a 29-storey residential tower atop a five-storey podium with partial sixth and seventh floors and includes:

- ground-floor commercial space;
- 168 strata units (29-storey tower) and 270 hotel units (15-storey tower);
- nine live-work artist studios;
- a floor area of 31,604.4 sq. m (329,423 sq. ft.);
- a floor space ratio (FSR) of 10.41;
- a maximum building height of 85.7 m (281 ft.) with additional height for rooftop amenity;
- 213 vehicle parking spaces and 393 bicycle spaces.

The application is being considered under the *Cambie Corridor Plan*.
