

NOTICE OF PUBLIC HEARING

650 West 41st Avenue (Oakridge Centre)

Vancouver City Council will hold a Public Hearing on:

**Tuesday, March 1, 2022 at 6:00 pm
to be convened by electronic means**

Council will consider amendments to the Zoning and Development By-law. If approved, the CD-1 (1) (Comprehensive Development) District would allow for additional market rental housing, moderate income housing and office. The proposal includes:

- 283 new market rental units;
- 130 new moderate income rental units;
- 35,876.9 sq. m (386,176 sq. ft.) of new office space;
- An increase in floor space ratio (FSR) from 3.71 to 4.10; and
- Height increases ranging from 1.1 m (3 ft.) to 30.2 m (97 ft.) to accommodate additional residential dwelling units and office floor area.

This rezoning application is being considered under the *Issues Report on Intensification or Larger Sites to Include Moderate Income Rental Housing and the Cambie Corridor Plan*.
