

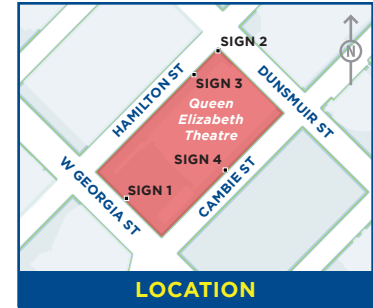
# NOTICE OF PUBLIC HEARING

April 1, 2021

## 688 Hamilton Street

Vancouver City Council will hold a Public Hearing on:

**Thursday, April 15, 2021 at 6:00 pm**  
to be convened by electronic means



Council will consider amendments to the Sign By-law. The application proposes the following amendments:

- Sign 1: The proposed sign will replace the smaller existing sign along W Georgia Street with a 5.33 m x 4.54 m double-faced free-standing electronic static image sign and illuminated LED side panel. The proposed sign is equipped with technology to adjust sign brightness.
- Signs 2 and 3: The proposed signs will replace the existing copy and screen with new copy and an electronic static image sign of the same size. Sign 2 along Hamilton Street is also proposing to add an illuminated LED-lit side panel.
- Sign 4: The proposed sign will replace the smaller existing sign along Cambie Street with a new 4.1 m x 2.23 m double-faced, free-standing electronic static image sign.
